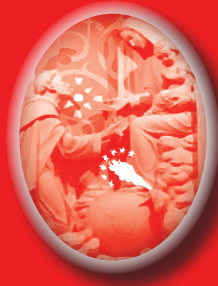

I am proud and overjoyed to report that they commended us on our operations in these two areas. Although we have a few minor items that we can improve, they informed us that our financial controls, our accounting of our income and expense, including payroll, our reporting and follow-up is one of the best that they have seen thus far.

They congratulated our staff for their efforts in these areas, especially Skip Roos, for his leadership of our financial management processes, and Theresa Eagan for her leadership of our child protection process. They told us that until they audited us at St. Dominic, in every other parish audited, they found issues in employee payroll and benefit administration and child protection. We broke their string! No issues for concern at St. Dominic! All of this good news is a further indication that we at St. Dominic Parish take seriously our responsibility to protect our children and to be good stewards of the resources you provide. Theresa and Skip both agree that this outcome could not be achieved without the fine efforts of all our parish staff, who so diligently accomplish their part, especially Jan Wright for her work with the payroll and Lisa McDonald for her work with child protection. Please join me in thanking them for their ministry.

Children and the Rite Of Christian Initiation Of Adults (RCIA)

Many of us are aware that the RCIA is the process through which adults come into the Catholic Church. What might be confusing to many people, both Catholic and non-Catholic, is how children who are no longer considered "infants" are to come to Baptism and full initiation in the Catholic Church.

The RCIA process is required not just for those whom society considers adults, but for those children who the Church considers adults for the sake of Baptism. **Therefore, once one reaches the age of reason (usually considered seven years old) he or she must be initiated in the Church through the RCIA process.** This requires Baptism, Confirmation and Eucharist – in that order. All three of these Sacraments of Initiation into the Catholic Faith are received at the Easter Vigil Mass for those who are in the RCIA process. This is not up to those coordinating the RCIA, the school administration, or even the Pastor. These are requirements of Church law (see below).

Following these rules, as you may have seen, often means that some children are confirmed and receive their First Holy Communion earlier than their peers. Some have expressed that this seems "unfair" to the peers, who must wait to be fully initiated, however, it is in fact what is required by Church law.

The full initiation of a child who has reached the age of reason is not something that happens lightly or without preparation. On the contrary, these children are required to go through formation in the parish's RCIA, even if they attend the parish school. Here at St. Dominic, our children in RCIA meet with their catechists throughout the year in preparation for their full initiation in the Catholic Church.

Pertinent Canons:

- (851 1f) **An adult who intends to receive baptism is to be admitted to the catechumenate (a phase of the RCIA process).**
- (852 B1) **The provisions of the canons on adult baptism apply to all those who, being no longer infants, have reached the use of reason.**
- (866) **Unless there is a grave reason to the contrary, immediately after receiving baptism an adult is to be confirmed, to participate in the celebration of the Eucharist and to receive holy communion.**

CHANGES TO VOLUNTEER VERIFICATION PROCEDURES - COMPLIANCE TO ARCHDIOCESE DECREE ON CHILD PROTECTION

The purpose of this message is to share with you changes to the volunteer verification processes/ confirmation of compliance to the Archdiocese Decree on Child Protection at St. Dominic Parish. Effective March 15, 2016, all prospective volunteers will be validated via a new "In-Compliance Volunteer List." This report will be updated on the 15th of each month (or the next workday if the 15th falls on a weekend or holiday.)

This process change is driven by a recent review of St. Dominic's VIRTUS accounts by Archdiocesan auditors. Changes are designed to help all volunteers adhere to the true purpose of the Decree on Child Protection, that is, awareness of the types of and signs of abuse, knowing how to communicate actual or suspected abuse situations, and knowing who is volunteering with our children.

What is changing?

1. Effective March 15, 2016 with the publication of the monthly "In-Compliance Volunteer List," all activity coordinators (teachers, lunchroom coordinators, PTO resources, Athletic Association sports coordinators, etc.) will need to confirm that their potential volunteers' names are on the Certified Volunteer report.

- Volunteers must be in compliance with their names present on the report that is published on the 15th of the month prior to the start of the particular activity. (i.e. the first team tryouts, the date of a field trip, first day of lunch room duty, date of the class party, etc.)
- If a volunteer's name is not on the In-Compliance report they are ineligible to volunteer until they meet the compliance requirements and are included on the next monthly report.
- Activity coordinators can access the list via the St. Dominic Parish Website > Ministries > Volunteering with Youth > "In Compliance" Volunteer Listing.

2. After confirming the eligibility of their volunteers, activity coordinators will submit their list of confirmed volunteers to the Parish Secure Environment Coordinator (SEC) prior to the start of the activity.

3. Coordinators for activities that last longer than 3 months (Room Parents, Lunch Room or Library Volunteers, etc.) are also required to recheck volunteers for compliance every 90 days and provide a list of these volunteers to the parish SEC.

As a reminder, compliance to the Decree on Child Protection for volunteers includes:

- 1.) A current (unexpired) background check and
- 2.) Remaining up to date on monthly continuing education bulletins (not more than 2 missed bulletins). Also, effective going forward, anyone who falls behind six monthly bulletins will be required to repeat the live training session to return to compliance and be able to volunteer.

The process to create a VIRTUS account, register for training and access monthly education bulletins remains unchanged and can also be found on the Parish website. 2016-2017 Tuition and Program Fees
Yes, Our School's Tuition and Program Fees
Are Being Reduced for Next School Year

Our K-8 Tuition: Although we presented a potential range of K-8 tuition increase for next year of \$0 to \$25, I am very happy to inform you that our parish school's K-8 tuition for next school year will be reduced by \$50 per student. This was proposed to and recommended by our Finance Council and approved by Fr. Jim and Deacon Mark. This is most probably the first time in our Parish School's history that a reduction in tuition has taken place. The reasons why this reduction has been accomplished are:

1. The success of our Parish Tuition Reduction Program. This program is contributing around \$70 per K-8 student towards next year's tuition and over \$5,500 to our Sr. Patrick Ann Tuition Assistance Fund. Please join us in giving a great big Thank You to Amy Walter and Pam Kent, who head this program. Their efforts and creative ideas have made this program a success. Also thank you to all those who participated in the program's many fund-raising activities. Your increased support of this program will continue to help us keep our tuition at a reasonable level.
2. The generosity of a deceased Parishioner. This parish member bequeathed a considerable sum to St. Dominic Parish to be used for education throughout the parish. Please keep this person in your prayers.
3. The generosity of our Parishioners in the Archdiocese of Cincinnati's 1Faith 1Hope 1Love campaign. St. Dominic Parish will get back 20% of the pledges the Archdiocese receives from our parish members. Fr. Jim has designated that these funds be used to assist our school families with tuition. Funds have already started to come back to our parish from the Archdiocese.
4. The continuation of our Parish Festival. Thank you to Julie Patrick and Joan Mattei for stepping up and taking on the leadership roles for this year's festival. Thank you also to the many others who have volunteered to chair and work in each of our booths. We appreciate the generous gifts of time and talent that each will be devoting to this very important parish event.

Our Pre-School Program Fees: We are happy to announce that our Pre-School Program Fees have been reduced by \$1 a day across the board, due to an increase in enrollment.

Our Before and After School Program Fees: We are also happy to announce that our Before and After School Program Fees will be reduced by 5% to 10% due to the increased participation of our School Families.

ST. DOMINIC ST. VINCENT DE PAUL SOCIETY

We wish to extend a very big "THANK YOU" to all the parishioners of St. Dominic. Through your generous donations we were able to provide help to many families.

From January through March of 2016 your St. Vincent De Paul Society was able to help 63 families and 195 adults and children in the Delhi area. Our total receipts for the first quarter of this year were \$7,702 from poor box collections, fund-raising projects, the schoolchildren and member donations. REQUIREMENTS FOR THOSE VOLUNTEERING WITH CHILDREN

As a reminder, all volunteers are required to attend one VIRTUS live training session. You can attend this training at any location at a date/time that works best for you. Preregistration is required. Find training locations, registration details and steps to create your VIRTUS user account at www.VIRTUS.org.

The second requirement for volunteers is to complete an online background check request. Payment for this is by credit card or "token" at the time of your online request. Contact the organization for which you volunteer to get information on obtaining a token for payment. To initiate the online background check, sign in to your [VIRTUS.org](http://www.VIRTUS.org) user account, click the "Toolbox" tab then click the selection.com background check link. STEWARDSHIP OF TREASURE

Remembering that everything we possess and earn is not ours, but gifts from God, who is the Creator of all things, and that we are merely stewards of God's resources, He calls each and every one of us to give according to the gifts we have been given. We are called to give our "First Fruits" in gratitude to God, and not what is merely leftover. He asks us to give our time, talents, and treasures. He calls us to give all 3, not just one in place of the others.

In Luke's Gospel, Jesus calls upon us, his disciples, to trust and depend on God to fulfill all of our needs and not to depend on money or possessions for our well being:

"Look at the crows: they don't plant seeds or gather harvest; they don't have storage barns; God feeds them! You are worth so much more than birds! Can you live a bit longer by worrying about it?... Look how the wild flowers grow; they don't work or make clothes for themselves. But I tell you that not even King Solomon with all his wealth had clothes as beautiful as one of these flowers..."

*So don't be all upset, always concerned about what you will eat and drink. Your Father knows you need these things. **Instead be concerned with His Kingdom, and He will provide you with these things.**"*

THE WIDOW'S OFFERING

SACRIFICIAL GIVING
